

We would rather operate without the need for detailed terms and conditions but unfortunately we have no choice. If there is any term or condition that prevents you from dealing with us, we will look at it, and if reasonable, will confirm in writing its exclusion as part of our agreement.

The following terms and conditions apply to all web site development and associated services offered by arsenadevelopment.com. By ordering services from mnconcept.fr you are agreeing to the following terms and conditions.

Ethical Issues

We reserve the right to refuse to provide services for a website or associated services which does not accord with our ethical policy or that we judge to be unfit due to content or otherwise. This includes, but is not limited by, sites containing adult oriented material such as pornography, sites which promote hatred towards persons belonging to any ethnic group, religion or sexual orientation and sites which infringe copyright or are contrary to UK or other relevant national or local laws or regulations.

Contract Commencement

The contract between mnconcept.fr and the client shall consist of the quotation with its specifications and these terms and conditions.

It may not be necessary to have a signature for the contract to commence, verbal communication, email communication or other exchange making it clear that the work specified is required to be carried out shall constitute commencement of the contract and a contractual agreement between the client and mnconcept.fr shall exist based on the quotation with its specifications and these terms and conditions.

mnconcept.fr cannot always guarantee to start work immediately on a commission but will arrange a date with the client as to when work can commence. An anticipated finishing date will be agreed and mnconcept.fr will do its best to adhere to that but cannot guarantee to do so in the light of circumstances outside its control.

Where in the instance that a time scale has been agreed, mnconcept.fr will not be responsible for any consequential losses to the client if the deadline is not met.

Development Standards, Web Standards, Accessibility

mnconcept.fr makes every effort to develop pages to current web standards and thus display well in the most popular current browsers, but cannot accept responsibility for pages which do not display acceptably in new versions of non-web standard browsers.

One version of the website will be created that will display well in all web-standard browsers and at all usual display resolutions.

The website will be acceptable to screen readers (used by those with visual impairments) and will adhere to guidelines for accessibility for those with visual, motor and other relevant impairments.

Development Process

mnconcept.fr will provide a draft of the development on its own server during development so that the client may view and comment upon the progress. When the website meets the specifications set out in the quotation with its specifications, mnconcept.fr will invoice the client for the full amount due.

On receipt of payment, mnconcept.fr will publish the website on the client's server, or provide the source code for the site via a download (or CD-ROM disc) for the client to upload.

mnconcept.fr uses its best endeavours to ensure the website and other services remain functional at all time. However, mnconcept.fr can not guarantee or warrant that the functions and content of the website or other services will be uninterrupted or error-free. Any problems will be dealt with as speedily as is appropriate to the content and function of the website and may be chargeable at our normal rate during working hours and at double that rate outside normal working hours.

Once the website and other services meet the terms of the quotation with its specifications any modifications to the development will be considered an amendment to the contract. In the absence of a maintenance agreement the time and costs involved in making such changes will be charged to the client.

In the absence of a maintenance agreement, mnconcept.fr will fix all errors notified to mnconcept.fr in writing within thirty days of the site being put live on the Internet. If errors are reported after more than thirty days the time and costs involved in making such changes will be charged to the client.

Supply of Content by the Client

The client undertakes to inform us prior to commencement of the project if there is a critical requirement to meet specific performance criteria.

If, during the development, the client does not supply the content required in order to complete the commission within the anticipated time frame, mnconcept.fr will invoice up to the full amount quoted. When the content is supplied there may be additional time costs involved due to the overrun of the project which impinges on the ability of mnconcept.fr to service other clients.

You grant Mnconcept.fr permission to utilize logos and any other company identity for the purposes of creating the website.

You agree to indemnify mnconcept.fr from any and all claims arising from your negligence or inability to obtain proper copyright permissions for all content supplied.

A design credit with a link to the mnconcept.fr website will appear on the main home page of your web site either in text or graphic format. The link will be designed to fit the overall design of the site.

You should provide mnconcept.fr with copies of your terms and conditions and any privacy statement that you wish to be incorporated into the design.

In the event that mnconcept.fr is unable to complete a website because of lack of text and/or pictures, then text will be added using "lorum ipsum" text and pictures using appropriate library pictures. At this point the website

will be considered completed and invoiced accordingly under our standard payment terms. Final text and pictures will be added when these are supplied by the client.

Acceptance

Acceptance procedure will be as follows:

- When Mnconcept.fr considers the development to be completed to the requirements of the proposal, the site will be uploaded to a test domain for you to preview and you will receive notification by telephone or email.
- You will have seven days from the notification to carry out an appraisal of the design and inform us of any changes required to correct any errors and comply with the quotation.
- mnconcept.fr will carry out the agreed amendments within seven days. You will then have a further seven days to appraise the changes to the design and inform us of any errors in the changes.
- After this period the development and design are considered as accepted and you will be invoiced for the outstanding costs and any further amendments are chargeable. The website will not be launched onto your domain until the final payment has been received.
- Any further amendments other than those covered by any maintenance agreement are then chargeable.

Copyright

All material, both text and images, supplied by the client and used in the construction of the client's web site, will remain the client's property. All such material will be assumed to be the property of the client and free to use without fear of breach of copyright laws. The client shall indemnify mnconcept.fr against all and any claims arising from the use of materials of any sort provided by the client or obtained under the direction of the client from third parties such as graphic designers.

The copyright for all material provided by arsenadevelopment.com, such as HTML code, graphics, photographs and text, will remain the property of mnconcept.fr until such time as payment has been made in full. They will then become the property of the client with copyright shared between the client and arsenadevelopment.com. This allows either party expeditiously to pursue any copyright infringement. Should the client wish to retain exclusive copyright this shall be arranged but the copyright of mnconcept.fr shall only be assigned if done so expressly and in writing to the client.

Background programmings, databases, CGI or Javascript produced by mnconcept.fr remain the intellectual property of mnconcept.fr unless otherwise expressly agreed in writing. No portion of the coding can be copied, duplicated or redistributed in any form without the express written permission of arsenadevelopment.com.

Testimonial, Reference and Links

mnconcept.fr and its sub-contractors retain the right to display graphics and other Web design elements as examples of their work in their respective portfolios. mnconcept.fr and its sub-contractors retain the right to refer other prospective clients to your website as testimonial or reference material. mnconcept.fr reserves the right to a reasonable credit on the website with a hyperlink to its own website. This would normally be on a contact page or somewhere accessible but no obtrusive.

Payment

A non-refundable payment of 50 per cent of the total fee is due with order, unless otherwise agreed, in which case payment is due upon completion of site. Whilst any payment due under the agreement remains outstanding, mnconcept.fr shall be entitled at its sole and absolute discretion to withhold provision of any goods or services it would otherwise be obliged to provide under the agreement.

mnconcept.fr expects payment by cheque, electronic bank transfer or cash within 14 days of the date on the invoice.

Payment may be made in Euros or US Dollars provided this has been agreed in advance and a sum sufficient to cover exchange commission and charges and any other additional expenses incurred has been added to the amount due.

Any payment returned by the bank or credit card company will incur a 100 € administration charge in addition to any charges made by the bank. This will be invoiced and will be added to the total outstanding debt owed by the customer.

Interest will be charged on all payments received outside of payment terms at the rate of eight per cent.

In case collection proves necessary, the client agrees to pay all fees (including all legal fees and court costs) incurred by that process.

If for any reason whatsoever we are unable to provide an agreed product or service in accordance with these terms and conditions our liability shall be limited in its entirety to a proportional refund of any fees paid by you for the service or product.

Using any other currency than Euro or US Dollars will use the exchange rate at the date of the signature from www.xe.com.

The website will not be launched onto your domain until the final payment has been received.

Subsequent annual subscription payments will be in advance on the anniversary of the initial payment.

If payments are not received by us on the due date we reserve the right to suspend the web site and other services until such time as payment is received in full (without prejudice to any other remedy available to us).

Domain Name Research and Registration

Where the client requests mnconcept.fr to research and register a domain name the domain name will always be the property and in the control of the client. If, for whatever reason, this is not possible then the client will be informed of the fact. All fees and costs incurred will be payable by the client.

mnconcept.fr will advise clients on selecting domain names and register these for them as requested at current rates, but cannot guarantee a certain name will be available. Mnconcept.fr reserves the right to make a charge of 50€ for any administrative work associated with subsequent hosting or domain name transfers into or out of our

facilities. Renewals are made automatically unless we are notified in writing 28 days in advance, but please note we accept no responsibility if a domain fails to be re-registered.

Search Engine Submission and Results

mnconcept.fr will submit a client's website to the major search engines. Further work based on keyword popularity analysis, search engine optimization based specifically around your organization and its 'competition' is best carried out by specialist contractors. This can be arranged but is not part of the contract unless specifically included in the quotation. Any subsequent amendments to the website as a result of professional analysis may be charged to the client. mnconcept.fr can accept no responsibility or liability if any search engine, online directory or search site chooses not to list a client's web site.

Website Hosting Services

Hosting services - where your website is stored on a server for delivery to website visitors - and email services are provided under a contract between the client and the chosen hosting and email provider (Internet Service Provider (ISP) and will be bound by the terms and conditions of that ISP. mnconcept.fr makes no commission on such recommendations or services and in recommending an ISP does so in good faith and cannot under any circumstances be held responsible or liable for any shortcomings or losses incurred as part of that contract.

Mnconcept.fr will normally arrange hosting for the website and the annual subscription for this will be included in the initial quotation for the design. FTP access details to your website files can be issued on request. mnconcept.fr accepts no responsibility for web server downtime or interruptions to service caused by circumstances beyond our control. Customers wishing to arrange web hosting and domain names away from mnconcept.fr can do so at any time. We will however advise you if the arrangements appear to be unsuitable for our requirements. If the website is to be hosted by another web host than arsenadevelopment.com, you agree to grant mnconcept.fr access to the web space via FTP.

mnconcept.fr shall be entitled to restrict bandwidth made available to the Client at any time in order to protect all and any Internet solutions provided by Mnconcept.fr Internet from time to time when necessary.

mnconcept.fr shall be entitled to temporarily suspend or disable a Client's services at any time in order to protect all and any Internet solutions provided by Mnconcept.fr Internet from time to time when necessary.

Website Maintenance

Where mnconcept.fr undertakes to maintain or update a client's website a system of communication will be established that meets the needs of both the client and of mnconcept.fr to carry out the maintenance to a service level agreed.

Payment for maintenance is usually by yearly fees paid in advance and is reviewed and renewable annually. Where the client cancels a maintenance contract with less than one month's notice, there will be charge of six months fees.

Where mnconcept.fr cancels a maintenance contract other than for a reason set out in Cancellation and Termination below, a refund of the fees appropriate to that part of the year remaining will be made.

In instances where the client does not come to a web site management agreement it is the sole responsibility of the client to manage the site. mnconcept.fr will no longer be responsible for the site upon completion unless an alternative agreement has been reached.

Email Newsletters and Marketing

Where mnconcept.fr provides services relating to management of email newsletters and other email marketing, payment is usually by yearly fees paid in advance and is reviewed and renewable annually.

Where mnconcept.fr provides email newsletter services we shall adhere to the legal requirements - particularly to the Privacy and Electronic Communications (EC Directive) Regulations 2003 - to the best of our ability and shall not condone or support any activity associated with indiscriminate spamming of email addresses.

mnconcept.fr accepts no responsibility for email server downtime or interruptions to service. Email accounts must not be used for "spam" emailing operations. Unless you have a support contract with us, once initially set up and operational, mnconcept.fr is not responsible for subsequent problems caused by the operating system of your computer.

Data Protection

Where the operation of the website or other services provided by mnconcept.fr involves the collection and administration of personal data the client is deemed to be the Data Controller and as such is responsible for notification under the terms of the Data Protection Acts and related regulations.

mnconcept.fr can arrange the required notification and the current fee for Notification and time and other costs will be payable by the client.

The client shall indemnify mnconcept.fr against any actions, costs and liabilities arising from the use in good faith by mnconcept.fr of personal data provided by the client or through the client's website.

Where your website involves e-commerce functionality, the client must ensure that suitable arrangements are in place to maximize security levels with regard to financial and personal information relating to the users of the website and other services. This may necessitate the use of secure electronic protocols, authentication certificates, encryption et cetera and may require the provision of secure server facilities and/or the use of a credit card clearing service.

Where a service is provided relating to e-commerce whereby visitors to the client's website can order goods or services through the website - whether through direct or indirect payment the client undertakes to ensure that all transactions are carried out legally and fairly, that the security of personal information and of financial information is maintained and that the collection and control of that data meets the requirements of the Data Protection Acts and regulations.

The client is solely responsible for complying with any laws, taxes, and tariffs applicable in any way to the website or any other services contemplated, and will hold harmless, protect, and defend mnconcept.fr and its sub-contractors from any claim, suit, penalty, tax, fine, or tariff arising from the website or other services provided.

Security

The client is responsible for the security and proper use of all Keywords and passwords and must take all necessary steps to ensure that they are kept confidential, used properly and not disclosed to unauthorized people.

The client must inform arsenadevelopment.com immediately if he has any reason to believe that any Keyword has become known to someone not authorized to use it or if any Keyword is being or is likely to be used in an unauthorized way or of any other breach of security.

Mnconcept.fr is not liable for any loss of confidentiality or for any damages arising from the client's failure to comply with these terms. You will be entirely liable for all activities conducted and charges incurred under your Keywords whether authorized by the client or not.

If you forget any Keyword you should contact us and subject to you satisfying certain security checks you will be given a new Keyword to enable you to use the Services.

Sub-Contracting

If necessary mnconcept.fr reserves the right, and the client hereby agrees, to allow the use of sub-contractors or agents to work on any aspect of the website or other services.

Quotations and Tenders

Tenders and Quotations are valid for thirty days from the date on the tender or quotation. All prices quoted may be subject to change after this period.

Consequential Losses

If for any reason whatsoever mnconcept.fr is unable to provide an agreed product or service in accordance with these terms and conditions our liability shall be limited in its entirety to a proportional refund of any fees paid by you for the service or product.

The entire risk as to the quality and performance of the website or other services is with the client. In no event will mnconcept.fr be liable to the client or any third party for any damages, including, but not limited to, service interruptions caused by acts of god, the hosting service or any other circumstances beyond the control of arsenadevelopment.com, any lost profits, lost savings or other incidental, consequential, punitive, or special damages arising out of the operation of or inability to operate the website or other services, failure of any service provider, of any telecommunications carrier, of the Internet backbone, of any Internet servers, your or your site visitors' computer or Internet software, even if mnconcept.fr has been advised of the possibility of such damages.

Unforeseen and Additional Costs and Expenses

The transfer of domain names to another server can sometimes become a complex and time-consuming matter. All administrative fees to third parties and the time taken to organize the transfer will be charged to the client irrespective of any quoted amount set out in the quotation with its specifications.

Additional costs incurred in the provision of: stock photography; electronic commerce software; online transaction processing solutions; domain name registration; web space; Internet connection provided by third parties are non refundable.

Additional features to websites, including extra database services, specific hosting requirements, animations that are not included in the quotation are subject to surcharge. In the event a feature is required which has not been included in the quotation mnconcept.fr will give notice prior to implementation and seek acceptance of the surcharge. The cost will be added to the final invoice unless the amount exceeds 1000€ in which case an interim half will be invoiced before implementation and the remainder will be added to the final invoice.

Standard charges

In the absence of agreed rates the following will apply for additional work:

- Clerical or data entry activity 30 € per day per person
- Design or development activity 60 € per day per person
- Senior management/programmer 170 € per day per person
- Traveling and subsistence on a costs as incurred basis

Advice and Consultancy

Any advice given in respect of software, hardware, programming, design, purchasing, hosting, training, upgrading, installing or any other advice, suggestion, recommendation or otherwise of any product or service provided by us or by a third party, whether introduced by us directly or indirectly is accepted by you as an opinion and as such you agree that prior to acting on any of the aforementioned that you will first obtain professional advice. You further agree to indemnify us of all liability with regard to any decision or action performed by you that may or may not be a direct or indirect result of any contact or dealing with us.

Our consultancy service and general advice is, by its nature, subjective. It is up to you whether you decide to follow our ideas and suggestions. It is not possible and we do not guarantee that any of those ideas and suggestions will increase traffic to your site, improve your ratings with search engines or boost sales.

Training

Endeavour to provide appropriate training as agreed and on terms agreed. The outcomes of training personnel in whatever activities agreed are not readily quantifiable and as such we cannot accept liability for any training we provide not meeting the client's or the trainee's expectations.

Right to Assign

This Agreement is personal to you and you may not assign it without our prior express written consent.

Should you transfer ownership of the website as part of a transfer of ownership of a business then the new owners will need to come to a new agreement with arsenadevelopment.com.

Communication and Site Visits

arsenadevelopment.com's preferred method of communication is by email. Invoices will be sent by email and shall form a legal document just as if sent by traditional post.

Extensive site visits should not be necessary and the majority of design/development approval will be undertaken using the Internet, electronic files or other means. In the absence of a maintenance agreement which will set out site visit arrangements, visits requested by the client beyond that which mnconcept.fr considers reasonable will be charged at 70 € per hour (including travelling time) plus reasonable travel expenses not less than the actual costs incurred.

The development process will be undertaken by telephone conferencing, sample Internet design publication on arsenadevelopment.com's website, file design submission on computer disk, or other method as appropriate to the client's particular circumstances.

Cancellation and Termination

mnconcept.fr may, by written notice, terminate the Agreement between us immediately upon the happening of any of the following events:

- You fail to pay any invoice which has become due
- You commit a material breach of any of the terms of the Agreement between us
- You enter into or propose a voluntary arrangement or composition with your creditors
- Reconstruction of your debts or your directors make a declaration of solvency for the purpose of a members' voluntary winding up, or if notice is given of a creditors' meeting in connection with a creditors' winding up, or if a special resolution is passed that you be wound up by the court, or if an administrative or other receiver is appointed, or if the court makes an administration order or order that you be wound up by the court, or if you cease to carry on business or are unable to pay your debts within the meaning of the Insolvency Act 1986 Section 123.

Should mnconcept.fr decide to terminate the Agreement between us immediately upon the occurrence of one of the above circumstances, we reserve the right to exercise any other rights which we may have against you.

We reserve the right to remove from the Internet any website or other service which we display on your behalf upon the occurrence of one of the above circumstances.

Should we terminate the Agreement upon the occurrence of one of the above circumstances, we will not refund to you any monies paid by you to us.

If at any point during the development a client wishes to cancel, they may do so but will be invoiced up to the full amount quoted based on the degree to which the work has been completed and on the extent to which time has been allocated to the project that cannot be effectively used to generate revenue that would be otherwise lost.

If a maintenance agreement is terminated for any of the reasons mentioned above a fee equivalent to six months charges will be payable.

In the event that mnconcept.fr terminates a maintenance contract for any other reason, a refund equivalent to the unused portion of the current payment period will be the maximum liability.

No refunds will be made for any part of any annual hosting and maintenance subscription remaining.

Waiver and Interpretation

Should mnconcept.fr waive any of these terms on an individual basis, this shall not affect the validity of remaining clauses or commit mnconcept.fr to waive the same clause on any other occasion.

These terms and conditions shall prevail over all terms and conditions of your customary practice or any previous course of dealing between us and you.

Any variation to these terms and conditions shall be inapplicable unless agreed between ourselves before we commence any work on your behalf.

Work, services or products are only supplied in strict accordance with these terms and conditions. The provision of work, services or products by us is only undertaken on the understanding that you have read and accept these terms and conditions in full.

By agreeing to these terms and conditions your statutory rights are not affected.

In the event that mnconcept.fr is not entitled to rely on a term or terms in this contract, then mnconcept.fr may also be allowed to cancel all rights and obligations under this contract, or to hold all other clauses as valid entirely at their sole discretion.

No terms or conditions endorsed upon, delivered with or contained in the client's purchase order, confirmation of order, specification or other document will form part of the contract simply as a result of such document being referred to in the contract.

The client must ensure that the terms of its order and any applicable specification are complete and accurate.

Reservation
